Confusion between field crews and receiving facilities about 'immediate' 'level one' or 'priority' patients delineation

Decided to follow the "CDC's field triage guidelines" by using RAMP

Change in verbiage from 'level one' or 'priority' to 'trauma activation' and permit receiving facilities to activate as they see fit for their facilities

Working to fit this into the Trauma Triage Field Triage

Is ACS in favor of RAMP field triage?

Valley medical directors opted not to implement this until 2023 in hopes ACS sends out their updated field triage guidelines
