- C. Patient Management Report Ryan Southworth, DO
  - 1. Categorization Cindy Roberts
    - a. Garth Gemar, MD reviewed the changes to the Categorization Questionnaires. There are now four different questionnaires based on the following facility types: General Hospital Emergency Department; Free Standing Emergency Department / Hospital Satellite Emergency Department; Small Non-Specialty Hospital Emergency Department; and Critical Access Hospital-Based Emergency Department. Additionally, Dr. Gemar presented the proposed questionnaire content that will help identify a facility's helicopter patient transport capability and availability. After the discussion, Dr. Gemar made a motion to approve the Categorization Questionnaire changes. Sandy Nygaard seconded this motion. Motion passed to approve the Categorization Questionnaire changes.
  - b. Air Medical Issues discussion was covered under Categorization Questionnaire review.
  - 2. RED Book Garth Gemar, MD
    - a. Central Regional EMS Guidelines.

The Valley Medical Directors group has changed their name to the Central Arizona EMS Medical Director Consortium. A brief overview was provided on the anticipated changes for the Central Regional EMS (CARES) Guidelines as discussed during consortium meeting in September. Changes will be further reviewed during the consortium's November 9 meeting. When available, AEMS will process the changes during next Board and Functional Group meetings.
